



RENTAL AGREEMENT

The User hires the road bicycle/s owned by Sport Lab s.r.l.u., head office in Bologna, Via Corticella no. 189 – hereinafter referred to as the "Renter" - in compliance with the rules and terms and conditions herein contained which the Renter has to apply.

The Renter guarantees that the bicycle/s hired is/are duly equipped for riding on paved road according to the existing law rules. Equipment: speed change gear, shifting device, handlebar-mounted V-brake or disc-brake system, steel or alloy frame, repair kit and accessories. Male city-bikes are equipped with rear luggage carrier. Female city-bikes are equipped with front multipurpose basket.

In order to hire the bicycle/s, the User must know, obey, accept and undersign the following rules:

- 1) When picking up the bicycle/s, the User should produce the Renter his/her valid identity document. The rental bicycle/s must be returned to the Renter at the advised and/or agreed time and date, at the agreed drop off point or in any other place previously agreed upon.
- 2) Upon bicycle/s pickup, the Renter and the User check its working condition: the User acknowledges that the bicycle/s is/are mechanically efficient and declares to have previously checked it/them.
- 3) The bicycle/s shall be used exclusively as transport means and shall be treated with care, common sense and diligence. Racing, reckless manoeuvres or exhibitions of whatever kind are forbidden. The User shall use the bicycle/s in a correct way so as to avoid any damage to the bicycle/s or to the equipment.
- 4) The use of the bicycle/s for any business purpose is forbidden. The use of the bicycle/s cannot be transferred to third party.
- 5) The User shall comply with the Italian Traffic Rules which he/she declares to be aware of. The Renter will not be liable for any incorrect use of the bicycle/s and/or non-compliance with the Italian Traffic Rules
- 6) The physical ability and skill of the user are requested for riding the bicycle. Therefore when hiring the bicycle/s, the User unconditionally declares to have the suitable ability and the appropriate competence to ride the bicycle.

7) Only the User is responsible for any event, damage and/or accident connected with bicycle/s riding and/or use, occurred during the rental period (from the picking up to the dropping off) and therefore he/she will be the only one liable for any damage to himself and/or to third party/parties and/or to property and/or to the bicycle/s. No compensation shall be claimed to the Renter.

8) In the event of damage to and/or breakage of the rental bicycle/s - except for tyre holes - the User shall have to refund the Renter for the relevant amount required by the Renter when dropping off the bicycle/s.

9) In the event the bicycle/s is/are stolen, not returned or returned with unreparable damage, the User will reimburse the Renter the bicycle/s market value amount equal to:

- 200 € each **city-bike** (standard version) / **folding-bike**
- 300 € each **city-bike** (premium version)
- 500 € each **touring-bike** / **mountain-bike** / **road-bike**
- 600 € each **electric-bike**
- 1000€ each **cargo-bike**

10) In the event of accessories damage, not returned or returned with unreparable damage, the User will reimburse the Renter the accessories market value as follow:

- 85 € each pair of shoes
- 85 € each couple pannier bags
- 55 € each helmet
- 45 € each single pannier bag
- 44 € each baby seat
- 36 € each couple of pedals
- 30 € each security lock
- 20 € each smartphone bag
- 18 € each pump

11) The use of the bicycle/s is reserved to adults or minors accompanied by an adult who is responsible for him/her.

12) According to the Italian Traffic Rules (articles nos. 186 and 187). the Renter can refuse to hire the bicycle/s to persons he believes they are not able to ride, or for any other reasons, according to his own and indisputable opinion.

13) In the case of bicycle/s failure, the User will drop it/them off at the place of rental agreement signature or in any other place previously agreed upon.

14) If the User undersigns the rental agreement, the User acknowledges he/she has unconditionally understood the terms and conditions herein contained, as well as the rental fees and rental times.
